1. Call to Order

John Gioia, Vice Chair of the Governing Board, called the meeting to order at 11:02 A.M. Vice Chair Gioia provided Zoom teleconference meeting instructions.

3. Public Comments

Public member Joshua Quigley from Save the Bay congratulated Amy Hutzel on her appointed position leading both Coastal Conservancy and the San Francisco Bay Restoration Authority (Authority). Mr. Quigley briefed the board on two items. First, he noted the front-page article in the San Francisco Chronicle about the Dutch Slough Tidal Marsh Restoration Project and how long it took to complete. 11. San Pablo Baylands Collaborative Protection and Restoration (CPR) Project Phase 2: Camp 4 Ranch Acquisition and Stewardship Project

Jessica Davenport, Project Manager of the Authority, presented the staff recommendation. Speaking in favor of the staff recommendation: Kendall Webster of Sonoma Land Trust. Resolution:

The San Francisco Bay Restoration Authority hereby authorizes the disbursement of an amount not to exceed one million three hundred seventeen thousand dollars (\$1,317,000) to Sonoma Land Trust to acquire and initially steward the 1,149-acre Camp 4 Ranch property in Sonoma County (Assessor's Parcel Numbers 128-491-005, 128-491-006, and 128-491-007) for habitat protection and restoration and open space preservation, with the potential to allow limited public access and recreation, as part of Phase 2 of the San Pablo Baylands Collaborative Protection and Restoration Project, subject to the following conditions:

1. Prior to the disbursement of funds for the acquisition, the grantee shall submit for the

review and approval of the Executive Officer of the Authority (Executive Officer):

- All relevant acquisition documents including, without limitation, the appraisal, purchase and sale agreement, deed, escrow instructions, environmental or hazardous materials assessment, and title report;
- b. A baseline conditions report; and
- c. Evidence that sufficient funds are available to complete the acquisition.
- 2. The grantee shall pay no more than fair market value for the property, as established in an appraisal approved by the Executive Officer.
- 3. The property acquired under this authorization shall be managed and operated for the purposes of habitat restoration and protection and open space preservation, with the potential to allow limited public access and recreation that is compatible with those purposes. The property shall be permanently dedicated to those purposes by an appropriate instrument approved by the Executive Officer.
- 4. Authority funding shall be acknowledged by erecting and maintaining a sign on the property or in a nearby publicly viewable area, the design and location of which are to be approved by the Executive Officer.
- 5. Prior to disbursement of funds for stewardship activities, the grantee shall submit for the review and written approval of the Executive Officer of the Authority the following:
 - a. A detailed work program, schedule, and budget.
 - b. Names and qualifications of any contractors to be employed in carrying out the project.
 - c. A plan for acknowledgement of Authority funding.

Findings:

12. Wetlands Regional Monitoring Program Science Elements

Heidi Nutters, Project Manager of the Authority, presented the staff recommendation. Speaking in favor of the staff recommendation: Christina Grosso and Tony Hale from San Francisco Estuary Institute, Advisory Committee Chair Martini-Lamb, Luisa Valiela from U.S. EPA Region 9, Dave Halsing from the South Bay Salt Pond Restoration Project, and Lisa Horowitz McCann from the San Francisco Bay Regional Water Quality Control Board. Resolution:

The San Francisco Bay Restoration Authority hereby authorizes the disbursement of an amount not to exceed two million, nine hundred and fifteen thousand dollars (\$2,915,000) to Aquatic Science Center (ASC), a joint powers authority, to implement two elements of the Wetlands Regional Monitoring Program for the San Francisco Bay—implementing the monitoring site network and aligning Authority performance measures with WRMP indicators, including support of the WRMP Lead Scientist for these two elements. Of the funds authorized for disbursement, the Executive Officer shall not disburse more than one-half (\$1,457,500) until after June 30, 2023. Prior to commencement of the project, the grantee shall submit for the review and written approval of the Executive Officer of the Authority the following:

- 1. A detailed work program, schedule, and budget.
- 2. Names and qualifications of any contractors to be employed in implementing the project.
- 3. A plan for acknowledgement of Authority funding.

Findings:
