#### 11. De-Pave Park

Karen McDowell, Deputy Program Manager of the Authority, presented the staff recommendation on behalf of Natasha Dunn, Project Manager of the Authority.

Speaking in favor of the staff recommendation: Amy Wooldridge of the City of Alameda.

#### **Resolution:**

The San Francisco Bay Restoration Authority hereby authorizes the disbursement of an amount not to exceed eight hundred thousand dollars (\$800,000) to the City of Alameda to complete a master plan, 30% design plans, and a community stewardship program for restoration and enhancement of De-Pave Park in the city of Alameda, Alameda County to provide for the park to have a range of habitats, from subtidal and tidal to upland, and public access amenities. Prior to commencement of the project, the grantee shall submit for the review and written approval of the Executive Officer of the Authority the following:

- 1. A detailed work program, schedule, and budget.
- 2. Names and qualifications of any contractors to be employed in carrying out the project.
- 3. A plan for acknowledgement of Authority funding.

# 12. Grassroots Ecology

The San Francisco Bay Restoration Authority hereby authorizes the disbursement of an amount not to exceed six hundred eighty-eight thousand sixteen dollars (\$688,016) to Grassroots Ecology to restore and enhance marsh-upland transition zone habitat along the San Francisco Bay Trail in Ravenswood Open Space Preserve and at Cooley Landing, work with East Palo Alto-based community groups to provide restoration training and organize stewardship events, and hire local young adults for restoration internships in San Mateo County. Prior to commencement of the project, the grantee shall submit for the review and written approval of the Executive Officer of the Authority the following:

- 1. A detailed work program, schedule, and budget.
- 2. Names and qualifications of any contractors to be retained in carrying out the project.
- 3. A plan for acknowledgement of Authority funding.
- 4. Evidence that all permits and approvals required to implement the project have been obtained.
- Evidence that the grantee has entered into an agreement with the Midpeninsula Regional Open Space District sufficient to enable the grantee to implement, operate, and maintain the project.
